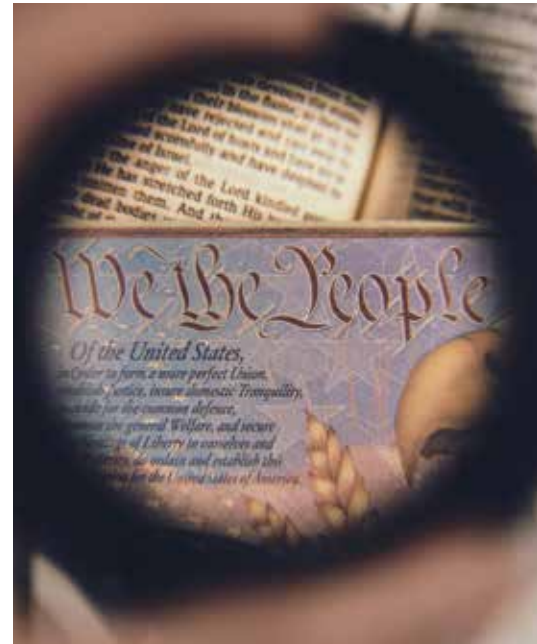
Our MISSION

Family

We represented a woman in both a protection from abuse and custody matter. Our client and her ex-husband have three children. Our client filed for a protective order following a custody exchange in which the children's father struck her and tried to strangle her. After this incident, the Father was charged with terroristic threats and strangulation. At the first PFA Hearing, Father requested a continuance in order to obtain counsel and to address the criminal charges. At the second PFA hearing, Father served Mother with a custody complaint and requested another continuance of the PFA hearing. We represented Mother at the Custody Conciliation Conference and based upon Father's pending criminal charges, he was granted no rights of custody. At the third PFA hearing, Mother was granted a final Protective Order. After the PFA, we continued our representation to the next step in the custody matter, which was the custody pre-trial conference. However, prior to the pre-trial conference, Father was charged with Involuntary Deviate Sexual Intercourse, Aggravated Indecent Assault of a child less than 13 years of age, Indecent Assault of a child less than 13 years of age and Corruption of Minors. With our continued assistance, our client was awarded sole legal and physical custody of the parties' children in the Final Custody Order.



LITC

MidPenn's Low Income Taxpayer Clinic (LITC) was established in 2015. The LITC helps low-income taxpayers who need assistance in resolving a tax dispute with the Internal Revenue Service. Our LITC attorney negotiates settlements, assists in audits and conducts educational programs that help taxpayers under the tax laws that directly impact their lives.

ELDER LAW

We represented a legally blind older adult. Our client learned from the individual who reads his mail and pays his bills that a \$3,500 withdrawal showed up on his bank statement. He went to his local bank branch and learned that a man had come into a branch in another county and claimed that our client was in the hospital in Philadelphia, and needed \$3,500 to come home. The bank gave this man the money. After learning this, our client closed both his savings and checking accounts. When closing his checking account, our client discovered that the woman who he had hired to help him clean had stolen several checks from his apartment. He filed a police report, and both individuals subsequently pled guilty to stealing our client's money. Between the two, they had stolen approximately \$14,000, leaving our client penniless. Our client then tried to get the bank to reimburse him the full amount of money that was stolen but he was only reimbursed \$200.00. Frustrated, our client spoke with his caseworker at one of the local shelters where he receives supportive services. The shelter caseworker referred the client to MidPenn, and we worked on his case with guidance from a volunteer attorney with the requisite level of expertise in banking law and regulations. Through our collaborative efforts, we were successful in getting the bank to return all of our client's money.



Housing

We represented a 38-year-old client with advanced multiple sclerosis. She, her daughter, and her grandson live in a Project-Based Section 8 unit. She came to MidPenn after the landlord alleged that our client's daughter was involved in criminal activity – in particular, a physical altercation – at the end of the street on which our client's unit is located. In support of his allegation, he said there was a “viral video” of the incident posted on Facebook that showed our client's daughter was involved in the altercation. When we viewed the video, it was clear that our client's daughter was not involved, but the landlord continued to maintain that she was involved. Given that the police had responded to the incident, we worked to get a copy of the police report. Although, the landlord's attorney subpoenaed the police requesting a copy of the report, his efforts met with no response to the request. Our attorney then worked with opposing counsel, the MDJ, and, a local Common Pleas judge to obtain the police report. Upon receipt and review of the police report, which proved that our client's daughter was not involved in the incident, the landlord agreed to withdraw the complaint, which allowed our client and her family to remain in their home.



M MEDICAL LEGAL PARTNERSHIP

When you visit a medical facility, you do not expect to meet a lawyer. However, many elderly, disabled, and low-income individuals and families find themselves facing legal problems that adversely affect their health, problems that the health care system is not equipped to resolve.

Through the Medical Legal Partnership, MidPenn works together with healthcare professionals to achieve better health outcomes by adding legal services to the health care toolkit. The MidPenn Medical-Legal Partnership attorneys tackle problems that the health care team could not otherwise easily solve—intervening with landlords to ensure home repairs are made; restoring utility services; securing food stamps, health insurance coverage, and Social Security income for patients whose benefits have been denied or terminated. Those we serve are often medically frail, and living in geographic and social isolation. They are unable to come downtown to seek services, but the Medical-Legal Partnership allows us to bring services to them in their homes or at a medical facility.

“My effectiveness as a lawyer is enhanced when I can do it side by side with the providers, the care navigators, the case managers, the clinical counselor, the chaplains, the pharmacist, the customer support specialists, the program managers, and all of our numerous community partners – sharing expertise, collaborating to help patients tackle their challenges.”

OMBUDSMAN

When a resident of a nursing home is not receiving the care they need, who will advocate for them?

“When a consumer of a long-term care facility is not receiving the care they need, who will advocate for them? Who will speak for them? Ombudsmen give the residents a strong voice. MidPenn has two Ombudsmen – one in Lebanon and one in Schuylkill County. They empower the residents to speak up for their rights, make referrals with legal issues, mediate problems, and ensure that the residents’ quality of life is maintained – all with consumer consent. The work is varied. Sometimes it is encouraging the consumers to speak with the nursing home staff about care or food preferences, helping a disabled resident obtain a wheelchair, or ensuring end-of-life issues are met with dignity. The Ombudsman works with the residents to get answers, solve their problems, and protect them.”
