


She made history as the first Black Legal Advocate at MidPenn Legal Services and later served as their first Black Paralegal.

## Client Secures Final Protection from Abuse Order with Legal Support

A recent client reached out to our office seeking help with a **Protection from Abuse (PFA)** matter after experiencing a series of escalating and distressing incidents involving the defendant.

In one particularly alarming encounter, the defendant engaged in a heated argument with the client, then proceeded to retrieve a knife from the

kitchen, standing in the doorway and asking threateningly, "Is this what you really want?" This incident followed a pattern of emotional abuse, including threats of self-harm and continued harassment after leaving the shared residence.

With the support and guidance of Counsel, the client was able to present her story to the court clearly and confidently. Counsel played a critical role in helping establish a pattern of abusive behavior, giving the court a full understanding of the situation and the need for legal protection.

As a result of her courage and the dedicated legal advocacy provided, the court granted the client aFinal Protection from Abuse Order, ensuring her safety and peace of mind. We are proud to stand beside survivors and support them in asserting their rights and protecting their well-being through every step of the legal process.

MidPenn Legal Services proudly received an\$18,200 grant from the Adams County Bar Foundation during the Law Day Celebration on May 1. Managing Attorney Nicole Sipe graciously accepted the award, which funds a vital custody contract position in Adams County.

This generous contribution enables Attorney Andrea Singley to continue providing essential legal advice and representation to individuals facing custody matters who cannot afford legal assistance. Adams County Bar Foundation Chair Miranda Blazek, Esq. presented the award, reinforcing the Foundation's commitment to expanding access to justice in our community.



MidPenn Helps Disabled Veteran Overcome Burdensome Debt



At MidPenn Legal Services, we believe that every client deserves dignity, respect, and a second chance—especially those who have served our country. Recently, our team had the opportunity to advocate for a 66-year-old disabled veteran facing a deeply stressful situation that jeopardized his financial and emotional well-being.

The client, a White, non-Hispanic man living with multiple severe health conditions, receives care from a VA nurse

three times a week. His only income consists of Social Security and veterans' benefits. Despite his limited resources and fragile health, he received a **Demand Notice** from the Pennsylvania Department of Labor stating that he owed **\$2,021.36** in unemployment overpayments—an amount stemming from a **\$885.00** overpayment dating back to 2001.

Confused, overwhelmed, and unsure of the origin of the debt, the client turned to MidPenn for help. Our attorney immediately contacted a UC Claimant Advocate and discovered that the debt was linked to an old "fault overpayment" for not reporting wages over 20 years ago. The client, however, had no memory of the original incident and had never filed an appeal. A lien was placed by the Commonwealth in 2007 and renewed in 2012.

Despite numerous attempts to communicate with the Unemployment Compensation Benefits Unit, our attorney was met with roadblocks. After exploring multiple avenues—including the potential for bankruptcy and outreach to other legal advocates—there appeared to be no clear legal path forward. But persistence is a cornerstone of our work. After weeks of research, outreach, and advocacy, our attorney reached a **Deputy Chief Counsel with the Department of Labor's Unemployment Compensation Division**. Upon hearing the full story, the Deputy agreed to take the matter under review. A formal request was submitted, including a detailed letter outlining the client's medical condition, reliance on VA support, lack of assets, and the significant stress caused by the collection notices. The **Department of Labor agreed to remove the lien and cancel the debt entirely** 

# MidPenn LITC Recovers Over \$8,000 in Tax Refunds

A 63-year-old client recently received a much-deserved victory after recovering four years of wrongfully denied tax refunds, totaling over \$8,000, thanks to the dedicated support of Attorney Bob Hamilton.

Despite filing his tax returns on time each year and properly claiming his refunds, the client faced significant setbacks when the IRS denied his refund claims and assessed a balance due of more than \$5,000. The issue



stemmed from the client's employer failing to submit his **Form W-2s** to the IRS—an error entirely outside the client's control.

Attorney Hamilton stepped in to advocate on the client's behalf, submitting key evidence including **bank statements** and **paystubs** that clearly, demonstrated the client's income and proper tax withholding. His efforts helped establish that the employer, not the client, was responsible for the discrepancy.

As a result, the IRS reversed the balance due and issued the refunds that the client had rightfully earned. This case is a powerful reminder of the critical role legal advocacy plays in ensuring justice and protecting the financial well-being of individuals—especially when systemic errors place the burden unfairly on taxpayers.
