

## MidPenn Legal Services Berks County Office 2017-2018 Fact Sheet



<u>MidPenn is free civil legal aid</u>. We are a legal emergency room for the poor. We provide advice and counsel to help very low-income families solve problems and get back on track.

<u>Case Types:</u> We handle critical civil matters: child custody, domestic violence, housing, elder law, public benefits and consumer. We do not handle criminal cases.

<u>Mission</u>: MidPenn Legal Services is a non-profit law firm providing free civil legal aid to low-income families in crisis.

<u>Vision</u>: We seek orderly resolutions for poor families with critical legal problems. We protect personal safety, stabilize housing, secure income, and obtain health care for those with nowhere else to turn.

2,924 residents in Berks County benefited from MidPenn's advocacy. \$764,675.77 in savings and economic benefits to Berks County clients and their communities.

The Legal Services Corporation provides 32% of our funds. Additional support comes from the Berks County Bar Association, Be Well Berks, the United Way of Berks County, Eastern District Bankruptcy Conference AIDSNet/Co-County Wellness, PA Commission on Crime and Delinquency and individual donors.
