

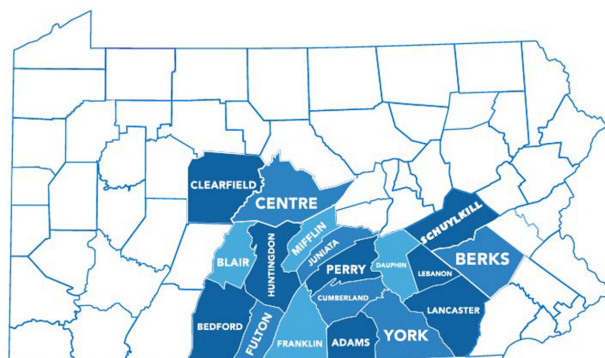
### Our Mission

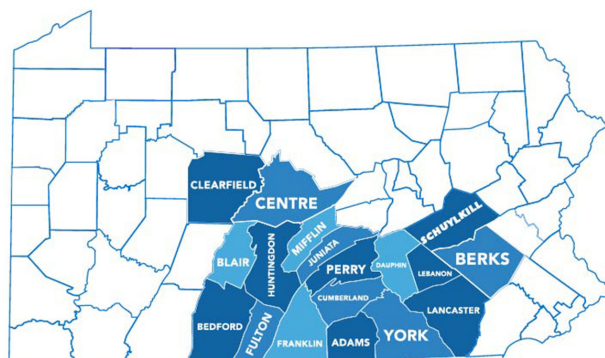
