Bridging the Justice Gap: Community Panel Explores Legal Deserts in Rural Pennsylvania

MidPenn Legal Services recently hosted a dynamic and throught provoking panel discussion focused on increasing access to justice in rural areas, with a special emphasis on the growing challenges posed by legal deserts - regions where there are too few attorneys to meet community needs.



The moderated panel by Rhodia D. Thomas, Esq., Executive

Director of MidPenn brought together leaders from legal, academic, governmental, and faith-based sectors to explore how collaborative strategies can address these service gaps and ensure equitable access to justice in places like Centre County. Panelists included Ryan Cummins, Esq., Managing Attorney, Jill C. Engle, Esq., Interim Association Dean, Penn State Law, Reverend Jes Kast, Pastor, Faith United Church of Christ, and Faith Ryan, Director with Centre County Office of Adult Services. The panel examined how legal services, in partnership with academic institutions and the faith community, are uniquely positioned to support vulnerable populations in rural Pennsylvania.







LITC Secures Life-Changing Tax Relief for Domestic Violence Survivor


The Low-Income Taxpayer Clinic (LITC) recently achieved a remarkable victory for a domestic violence survivor, eliminating more than \$200,000 in federal income debt she had jointly owned with her ex-husband.

For ten years, our client worked at her ex-husband's pizza shop, unaware that he had failed to pay federal income taxes. Controlled by years of physical and emotional abuse, she was never allowed to question financial matters or make decisions.

After carefully reviewing her medical and financial records, Attorney Hamilton filed a Petition for Innocent Spouse Relief with the IRS for tax years 2017-2020. The IRS determined she qualified for relief, removing her from liability for the joint tax debts.

This outcome not only lifted an overwhelming financial burden but also gave our client a fresh start toward rebuilding her life free from abuse.

On May 28, Attorney Doug Hearn was recognized with the Friend of the Center Community Service Award during Centre Safe's 50th Anniversary Award Luncheon. The award celebrates Doug's longstanding commitment to advancing safety, justice, and advocacy for survivors of domestic and sexual violence in Centre County. His dedication and collaborative spirit have made him a trusted ally to Centre Safe and a powerful advocate for the communities we serve.





MidPenn Engages at "Stop the Violence" Community Outreach Event

Throughout the day, Leslie and Yinet connected with community members to share information about the wide range of services offered by MPLS. In addition, they distributed contact information and general resources from the York County Bar Association (YCBA), ensuring attendees left with valuable connections and tools to address their legal needs. Free Driver's License Restoration Clinic Serves York County Residents

Recently, MidPenn Legal Services partnered with the York County Bar Association and the York County Clerk of Courts Office to host a free Driver's License Restoration Clinic in York County. These clinics provide critical legal services to help individuals navigate the oftencomplex process of regaining their driving privileges after a suspension or revocation.



The event offered free advice, guidance, and hands-on support to residents - particularly those from underserved communities - seeking to restore their licenses. Many participants left with clear next steps, and in several cases, solutions were found on the spot. In total, the clinic assisted 39 individuals, providing both direct resolution and essential guidance for future action.
