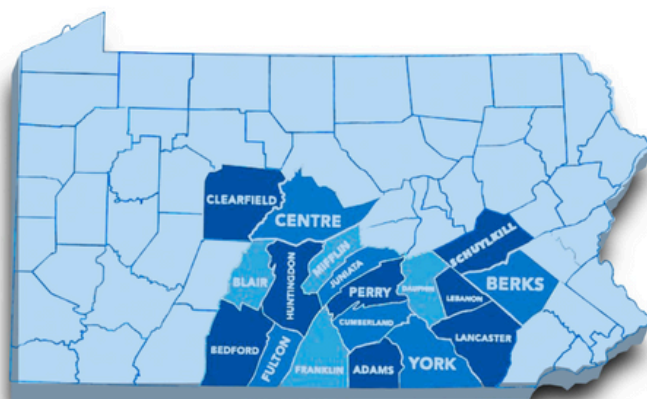


**MidPenn Legal Services fights for low-income families and domestic violence survivors, delivering free legal aid that transforms crisis into stability.**

The Pennsylvania Legal Aid Network provides 51.9% of our funding from various sources including, Interest on Lawyer Trust Accounts, state and federal Title XX, filing fee add-ons, and the Disability Advocacy Project. The Legal Services Corporation provides 30.1% of our funds. Additional support comes from the Dauphin County Bar Association, Domestic Violence Services of Cumberland & Perry and individual donors.

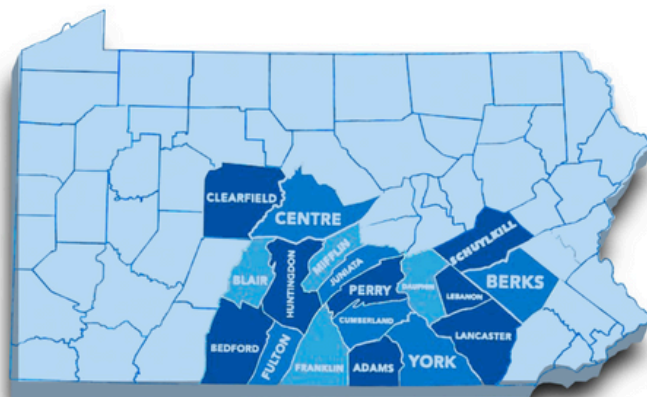
