Private attorneys volunteer their time and expertise to handle cases for free, often through a local bar association.

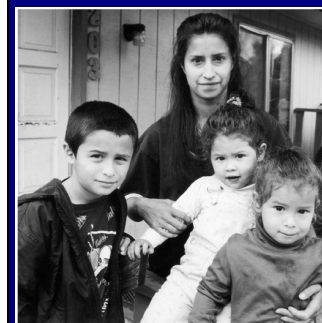
MidPenn Legal Services Has Community Support

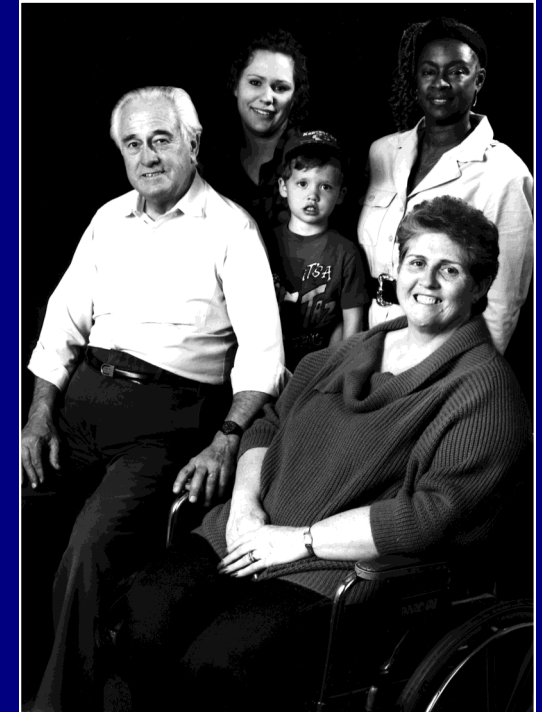
