The Pennsylvania Legal Aid Network provides 51.9% of our funding from various sources including, Interest on Lawyer Trust Accounts, state and federal Title XX, filing fee add-ons, and the Disability Advocacy Project. The Legal Services Corporation provides 30.1% of our funds. Additional support comes from the Centre County Office of Aging, the Centre Foundation, the Centre County Housing and Land Trust, the State College Community Land Trust and individual donors.
